Looking back, I am delighted to report that 2023 was a record-breaking year in more ways than one. LPAC **endorsed more candidates than ever before,** setting a new standard for the reach and impact of our work. With a **historic number of LGBTQ women and nonbinary people stepping up to run for office,** LPAC was often the first place they turned for help, and we were honored to be there for them. The crucial support we offered candidates this year was only possible with the support of you, our stakeholders.

From electing the first out trans state senator in the southern United States to defeating pro-book ban, anti-LGBTQ school board members, our candidates up and down the ballot made powerful statements with their victories this cycle. Voters rejected the anti-LGBTQ rhetoric of our opponents and embraced our candidates, LGBTQ women and nonbinary people running powerful community-based campaigns.

It was thrilling to see California Senator Laphonza Butler make history this year as the first openly LGBTQ Black woman to serve in the U.S. Senate, and LPAC is hard at work building a pipeline of incredible candidates to follow in her footsteps. Together, we are building the political power of LGBTQ women and nonbinary folks across the country, winning seats at the table where decisions are made. Let us celebrate our victories in 2023 and redouble our commitment and efforts as we enter what is certain to be a crucial election year for our entire community. As always, thank you for your steadfast support of LPAC's work. Onward together!


CANDIDATE ENDORSEMENTS


This year, in what is considered an "off-year" for many political organizations, LPAC endorsed 130 candidates, the most in organizational history! We supported candidates running for major city councils, state legislatures, and school boards, and provided early endorsements and contributions for incumbents and competitive open seat candidates ahead of 2024.


Compared to past off-year election cycles this is **more than triple** the number of candidates LPAC has ever endorsed during an entire year — the previous record was 36 endorsements in 2021. 90 of our endorsed candidates had 2023 elections while the remaining 40 have elections in 2024.



SUCCESS STORIES:

ИAKING HISTORY IN STATE **LEGISLATURES**

Danica Roem won her election to the Virginia State Senate to become the first openly trans state senator elected in the U.S. south and only the second openly trans state senator in the country. Roem prevailed after Gov. Glenn Youngkin spent over \$500,000 supporting her opponent and employing anti-trans rhetoric throughout the district and state.

Attorney **Luanne Peterpaul** flipped a Republican-held seat in the New Jersey General Assembly. This is a historic win, as she will be the first-ever openly LGBTQ woman to serve in the New Jersey State Legislature. Until Peterpaul's election, New Jersey was one of the last states that had never elected an openly LGBTQ woman to serve in the legislature.



I'm grateful for LPAC's endorsements, donations and support for all four of my campaigns for the Virginia General Assembly. LPAC's steadfast support for electing LGBTQ+ women and non-binary people has been an essential part of my coalition. This year, LPAC made direct contributions with additional, direct financial support from LPAC board members. When I launch my re-election campaign for 2027, LPAC will — as always — be on my calls to make for Day 1. $\blacksquare \blacksquare$

As a member of the LBGTQ community, I know firsthand how important it is to have support in all ventures, and especially when running for office. SUCCESS STORIES:

INS IN BIG CITIES



As a trans candidate running a historic campaign in Tennessee, I faced questions of viability from a range of stakeholders, but from the moment I got in touch with LPAC, LPAC jumped behind my campaign and offered its full support. LPAC's endorsement was invaluable in elevating my campaign to a national network and helping me get across the finish line to become the first out trans person ever elected in Tennessee.

The financial and strategic support LPAC provided played a vital role in the success of my re-election campaign. While receiving support as a first-time candidate is always crucial, continuing to receive tangible support as an incumbent facing a competitive race is key to protecting LGBTQ representation. As the only LGBTQ Commissioner and the first person of color ever elected to the Port of Tacoma Commission, I am proud to have had LPAC as an important part of my re-election coalition.

In September, veteran and LGBTQ advocate Olivia Hill was elected to an At-Large seat on the Nashville City Council, becoming the first out trans person elected in the state of Tennessee. While many other groups sat out and questioned Hill's viability, LPAC stood with her. Hill's victory makes a powerful statement in a hotbed state for anti-trans attacks.

In November, **Rue Landau**, a civil rights attorney and housing organizer, became the first-ever openly LGBTQ person elected to the Philadelphia City Council, and nonprofit leader **Joy Hollingsworth** won a seat on the Seattle City Council, restoring LGBTQ representation to the Council - Seattle's thriving LGBTQ community had gone without representation in city government since 2021.

Our incumbent council members in major cities also cruised to re-election: New York City Council Members Crystal **Hudson** and **Lynn Schulman** handily won their races and Boston (MA) City Councilor **Liz Breadon** overcame a challenger. In April, Madison (WI) Mayor Satya Rhodes-Conway and Tampa (FL) Mayor Jane Castor won re-election. And in Minneapolis, Council President **Andrea Jenkins**, the first out Black trans person elected in the country, won her reelection against a formidable challenger in a very close race.

BUILDING THE LINE OF DEFENSE: **SCHOOL BOARDS**



Many of our endorsed school board candidates faced anti-LGBTQ opponents this cycle. Their successes on election night demonstrate that voters are tired of the anti-LGBTQ attacks that only harm our children and our communities. In October, LPAC hosted a pre-election virtual briefing on the state of school board races across the country, featuring four of our impressive school board candidates facing anti-LGBTQ opponents. This briefing gave our network a chance to hear directly from candidates on the frontlines.

Amelia McMillan won election to the Central York School Board in Pennsylvania, in a district that passed the largest book ban in modern history in 2021. McMillan was the subject of anti-LGBTQ attacks from her pro-book ban opponents, but voters clearly rejected this rhetoric, electing McMillan's entire pro-equality slate.

In Virginia, **Robyn Lady** won a seat on the Fairfax County School Board, defeating a Gov. Youngkin-backed opponent. In Ohio, Toledo School Board President **Sheena Barnes** won a write-in campaign to defend her seat against a Moms for Liberty-backed challenger.

While not all of our endorsed school board candidates won their races this cycle, we are dedicated to staying engaged with our endorsed candidates and encouraging them to run again in the future. In California, Sasha Ritzie-Hernandez was narrowly unsuccessful in a special election for a seat on the Oakland School Board, but is already building upon her hard work to launch an even stronger campaign for the same seat in 2024.





While many national organizations focus their resources on higher levels of office, LPAC made clear from the get-go that school board races were a priority for them. While I did not win my election, the steadfast support of coalition members like LPAC played a significant role in my decision to run again. We know that candidates with intersectional identities face disproportionate barriers when running for office; our opponents rely on these barriers to discourage us from running, but LPAC celebrates my identity—as Afro-Indigena, queer and nonbinary—as my greatest strength. I look forward to building on the important groundwork I laid this past cycle and, with LPAC's support, coming back with an even stronger campaign in 2024.

Not only did LPAC make an impactful direct contribution to my campaign, but they were also there to provide strategic support and solidarity throughout the campaign. When I learned I would be a write-in candidate, LPAC was there for me. When I faced Governor Dewine and the state to protect the autonomy of school districts across Ohio, LPAC was there for me. And one week out from election day, LPAC was there for me and my fellow endorsed school board candidates when they invited me to participate in a school board panel that allowed me to further elevate my campaign to LPAC's national network. It is not always easy running for and serving on the School Board in Toledo, Ohio, but LPAC had my back every step of the way.

LPAC directly donated \$105,000 to our endorsed candidates this year. Staff spent more than 91 hours providing direct support to our candidates, reviewing voter contact plans, polling, messaging, and advocating to other organizations for additional support to our candidates. We also hosted events across the country, expanding our footprint to southern California with a successful event in Los Angeles. These inaugural events allow us to expand our network, introduce our candidates to new supporters, and to increase the reach and impact of our work. In 2023, LPAC made the strategic decision to endorse and contribute to priority federal candidates early, ahead of what is certain to be an expensive and competitive Presidential cycle. With an historic **11 endorsed congressional candidates**, this early investment is crucial to increasing LGBTQ women's and nonbinary representation in Congress. We have already sent **\$34,500** to our endorsed federal candidates running in 2024.

We have endorsed and maxed out for the primary to **U.S. Senator Tammy Baldwin**, who will have a challenging race for a third term in Wisconsin. In the U.S. House, **Rep. Angie Craig** and **Rep. Sharice Davids** have again been labeled "Frontliners" who will face competitive re-elections. We have endorsed and contributed to them both, as well as to **Rep. Becca Balint.**

In addition to defending our incumbents, we have a real opportunity to **double LGBTQ women's representation** in the U.S. House next year with **seven LGBTQ women running for open seats.**

The daughter of Cuban exiles who fled Castro's communist dictatorship and became successful entrepreneurs, Janelle Perez is an advocate, policymaker, and small business owner. After graduating from Florida International University, Janelle moved to Washington, D.C. and began her career on Capitol Hill. While seeking her Master's Degree from The Johns Hopkins University, Janelle worked for a non-profit where she led the educational and advocacy activities to support federal funding for the Global Fund to Fight AIDS, Tuberculosis, and Malaria. At the age of 28, Janelle was diagnosed with Stage IV Follicular Lymphoma, an aggressive cancer. After her diagnosis, Janelle moved to Miami in order to prioritize her health and start a family with her wife, Monica. Today, she is one of the owners of a Hispanic-owned and family- owned Medicare company in Miami-Dade County. Janelle was the Democratic nominee in the election for Florida State Senate District 38 in 2022. She was endorsed by LPAC in that election. A graduate of Florida International University and The Johns Hopkins University, Janelle currently lives in Miami, FL with her wife and two daughters.
